SUMMARY OF COMMENTS

Important Strengths:

Of the families that did respond....

- 100% aware of school's online safety policy
- 100% felt the school's website is useful in providing support for online safeguarding issues
- 100% felt able to keep their child safe online.
- 100% had rules in place to limit Internet/computer time.
- 100% said they would know what to do if their child accessed unsuitable websites.
- 80% had access to computers in a family room where supervision could take place.
- 80% said they would know what to do if their child was a victim of online bullying.

- 100% had strategies to deal with unsuitable internet content.
- 80% said they would attend an online safety event in school.

Areas of Concern:

Of the families that did respond....

- 20% were not aware of the Acceptable Use Policy (but had signed it)
- 20% didn't know what their child did online.
- 20% didn't know how to check on who their child was talking to online.
- 20% had access to computers in a bedroom unsupervised.

Key Findings:

- Very low response to the questionnaire reflecting the ongoing difficulty in engaging families 24%
- Families are signing the AU Agreement without reading/understanding it.
- Evidence of a lack of awareness of online dangers -
 - Unsupervised access to internet
 - o unaware of internet activity/conversations experienced by their child
- Willingness by some families to engage with school & online safety.

Actions:

- Focus on Online Safety in school to correspond with SID 2018 (February) to raise awareness of children & families.
- Plan an 'informal' Online Safety Information event for families using suggested days from questionnaire.
- Online Safety Newsletter with advice / support for families.
- Home visits discuss AU agreement with families to check understanding.
